#### **Probationers Conference and visit to Lusaka**

# March and May 2013

The Probationers' Conference took place in March 2013 at Rocky Valley UPCSA Centre. In addition to the eleven Probationers and two ministers being prepared for admission into the UPCSA, there were some special guests. The Convener of the Ministry Committee of the Church of Scotland, Rev Neil Dougal together with the Secretary of their Ministry Committee, Rev Marjory McPherson stayed with the Probationers at Rocky Valley for the first week. They took part in most sessions and also lead a few imparting valuable information and experiences from their side. This was the first of visits and exchanges which it is hoped will continue to enrich both us and them for the foreseeable future.

In addition, the Moderator and Ministry Convener of the UPCSA, Rt. Rev Rod Botsis and Rev Awedzani Nemaukhwe were able to be with the Probationers for three days. The presence of these significant people conveyed to the Probationers a sense of their own value and importance to the future of the UPCSA and God's ministry. Both the Moderator and Ministry Convener shared with the Probationers from their vast experience of ministry and the importance of one's commitment and determination to serve the Lord, and only the Lord.

By the end of the Conference it had become clear the extent to which the UPCSA is blessed with talented and hardworking people, for at no time did the need arise to call upon people to lead or teach from outside the UPCSA family. Two of our guest speakers, Thando Mpambani and Jaco Bester were

themselves Probationers as recently as 2009. Thando spoke on his experiences in the ministry and the importance of keeping one's focus on God while Jaco lead the Probationers through the historical events that brought about the need for Confessions of Faith and then taught on the structure and contents of the new UPCSA Confession of Faith.

The theme for the regular morning exegesis classes was: "Do not be afraid". These are words that can be found in many and differing situations from the beginning of the bible to the end. For many preparing to go into the ministry, fear in one form or another is a very real prospect and emotion.

On Sunday 10<sup>th</sup> March the Probationers were hosted by St John's Presbyterian Church in Turffontein. The Probationers were responsible for the Children's address and well as the sermon while our Scottish guest jointly celebrated the Communion by sharing the liturgy. At the end of the service a very valuable time was experienced when we met not only the congregants for tea but also spent an hour with the Session and their Minister, Rev Ndoda Mbuyisa. They shared with us not only the joys but also the challenges facing a congregation going through transition as they are.





Amongst some of the outings that the Probationers did was a visit to Constitutional Hill and the prisons that once held many prominent opponents to Apartheid, including Nelson Mandela during the Rivonia trial. Probationers found the memory of despair evoked by the visit to the prisons and the contrast of hope with the Constitutional Court building next door, built with many of the bricks that were once part of the walls of captivity, very moving. They were able to spend regular and valuable time reflecting over and sharing with one another on what they felt the Lord to be doing.

The town in which Joseph was placed happened to be the home of the former President of the ANC and first African Nobel Peace Prize winner, Albert Luthuli. His home in the little town has been turned into a museum which Joseph and the Ministry Secretary were able to visit.

Thursday 2<sup>nd</sup> May was the meeting of the College Board where our Moderator and Ministry Convener were presented to the Board. The evening meal, which was organized by the students was graced by the Moderator of the Synod of Zambia, Rev Jane Nyirongo as well as a member of the Ministry Committee who lives in Lusaka, Rev Edward Chirwa. During the evening each person present had a turn to say something about him/herself so that people could know each other as fellow Christians rather than as persons holding various offices in the church. New students at JMTUC were presented with their copy of the Manual of Faith and Order. They were

encouraged to not only read its contents but also to see the Manual as guidelines to leading a congregation in a transparent way so that all members have a sense of ownership and inclusion.
