

ASSEMBLY BUSINESS COMMITTEE

Supplementary Report to the General Assembly 2021

1. INTRODUCTION

We give God the glory for giving us this opportunity to serve Him and His Church in this committee. Appreciation and thanks to the entire UPCSA for trusting us with such a high responsibility of looking after the business of the General Assembly. It wasn't easy but it was worlth it. We give thanks to God almighty for bringing us this far, we can only say EBENEZAR (1 Samuel 7:12). Following after the words of the Apostle Paul who encourages us to give thanks to the Lord at all times and in all circumstances (1 Thessalonians 5:16), we too choose to give thanks under the current circumstances. "We have been hard pressed on every side but not crushed; persecuted, but not abandoned; struck down but not destroyed" (2 Cor. 4:8-9). In short, the COVID-19 times have been very difficult times for UPCSA as well as for the globe.

3. TERMS OF REFERENCE

The following are the terms of reference for the ABC:

- a) To organise meetings of the General Assembly and Executive Commission.
- b) To draw the agenda for the General Assembly and the Executive Commission.
- c) Formulate the Standing Orders of the General Assembly and the Executive Commission.
- d) Taking responsibility for conducting of the business of the General Assembly and Executive Commission.
- e) Ensure Implementation of decisions of General Assembly and Executive Commission.
- f) Attend to matters that may arise between General Assembly and Executive Commission.
- g) Ensure the preservation of the UPCSA organization memory (Repository)as drawn from the decisions of the General Assembly and Executive Commission. Guided by these terms of reference ABC has been carrying out its business.

4. SET GOALS FOR THE ABC

- To Offer support to the Central Cape Presbytery as they host 2019 EXCOM and 20th Anniversary celebration of the UPCSA.
- To deliver a successful EXCOM and UPCSA 20th Anniversary Celebration.
- To distribute all EXCOM decisions.
- To support Drakensberg Presbytery as they host 2020/2021 General Assembly
- To deliver a successful virtual General Assembly.
- To distribute all papers of General Assembly and decisions of the General Assembly.
- Attend to any matter that might arise in between EXCOM and General Assembly.
- To Monitor and Evaluate the UPCSA strategic plan.

5. ORIENTATION

The Clerk of the Assembly and the IT team have sent out the Orientation booklet and the Zoom Etiquette document which help us to know how to address ourselves during this Virtual General Assembly. We encourage all the commissioners to familiarize themselves with these two documents since there is no orientation that shall be done during the sitting of the Assembly according to the 2012 General Assembly decision. Three dry runs were conducted to help commissioners to accustom themselves with the way things will be done for the next few days. All this was done so that we don't leave anyone behind. We are confident that all commissioners know what to do. Should there be any problem, the IT team members will be on standby and they have also identified some local personal to help with any challenges that may arise. We have over 18 connection clusters where our commissioners will be connecting from, at the same time we have other commissioners that are connecting to this meeting as individuals. We have 14 Insaka groups that have been created for this Assembly.

This meeting will be a hybrid of virtual and a bit of face to face meeting. The current arrangement was necessitated by the current COVID-19 prevailing circumstances.

This meeting will use the Westminster model of decision making during the Executive session and then the rest shall be under the Consensus decision making Model. For this reason we encourage all commissioners to refer to the orientation handbook. All the proceedings of this General Assembly shall be recorded; this is in standing with the 2018 General Assembly decision. We wish to encourage all commissioners to ensure that they attend all the sessions of the consensus model namely Listening Session, Insaka Session and the Decision Session. Devotions are at the centre of our spirituality. Commissioners are encouraged to look at devotions as an integral part of our discerning process.

6. MINUTES OF 2019 EXECUTIVE COMMISSION AND 2020 EMERGENCY GENERAL ASSEMBLY

Minutes and decisions of 2019 Executive Commission and those of the 2020 Emergency General Assembly were sent with the papers of the 2021 General Assembly as a way of reporting and for Adoption in keeping with the Manual of Faith and Order. We wish to express our thanks to the Presbytery of Central Cape for a success in hosting of the 2019 Executive Commission and the 20th Anniversary Celebration of the UPCSA. This was quite a mammoth task which they managed with exception.

7. VOTING FOR MODERATOR DESIGNATE, THE AARP AND THE COURT OF ASSEMBLY

Voting for the Moderator designate, the Court of the Assembly and AARP shall be conducted using the electronic platform provided by the IT team. Announcement indicating the day and time when voting shall be conducted shall be announced during the listening session. When that time approach all business of the Assembly shall be suspended to give way to the voting exercise. Voting shall be concluded within five minutes and the results announced immediately. The announcement is to be made as a way of insuring that all commissioners are given enough time to participate. The election shall be considered as valid only if 75% or more of the commissioners present cast their vote. The Moderator shall announce the names of the persons who have been appointed to various positions according to the votes casted.

8. ADOPTION OF THE PROPOSED AGENDA

The preliminary Draft agenda was sent to all commissioners with the General Assembly papers. What is tabled as a final Draft Agenda is one that has received input from all the Conveners of all Assembly Committees.

Commissioners should note that in putting together the agenda for each Council, the ABC also takes into account the "Topical Issues" that appear to be subjects of debate within the denomination; Christian community or Countries where our membership is found; as well as events worth celebrating or remembering. Opportunity is created through the Agenda of the Council for the UPCSA family to express her views on such issues or celebrate such memorable events. In the same vain if any Presbytery, Congregation or a Commissioner is having any celebration during our sitting please pass on that information so that we can celebrate with you.

9. STANDING ORDERS

The Standing Orders for the 2021 General Assembly have been developed by the ABC and are now brought to this Council for adoption to guide the ordering of its business. These were sent early with the 2021 General Assembly papers for your consideration.

In addition to the Standing Orders the IT team sent the 2021 General Assembly Zoom Etiquette document which become part of the standing Orders of the 2021 Virtual General Assembly.

9. RECORDS

Each time the General Assembly sits Presbyteries and Assembly standing Committees minute books are attested by the General Assembly Moderator. The current arrangements pose a logistical challenge to get all the minute books to the venue of Assembly. We therefore propose that at this Assembly we are not going to have records attested. Another method shall be advised for future use and reported at the EXCOM.

10. CONVENERS CONSULTATION

The Conveners consultation was successfully held and all the Committees were represented. The COVID 19 pandemic created an opportunity which we did not have in the past. We were able to host more convener consultations at very low cost since we could easily use the zoom facility. During these consultations a number of issues were dealt with. Conveners were encouraged to line up their work with the UPCSA strategic plan. These consultations and the use of the virtual meetings helped to cut down costs whilst helping us to move at the same pace with all the committees. Now that we are becoming more comfortable with virtual meetings we wish to encourage all committees to make use of this opportunity to do their work. Going forward the ABC committee shall continue to hold conveners

consultation virtually.

10. DECISIONS OF THE GENERAL ASSEMBLY AND THE COMPLIANCY LEVELS

We notice with dismay the low compliancy levels to Assembly decisions at different levels of the denominational structure. We wish to remind all members of our denomination that once a decision has been made by the General Assembly it is binding to all. We wish to encourage high compliance levels at all structures levels of the denomination. When there is no leadership, everyone does as they please (Judges 17:6, 21:25). This matter touches very core of our Presbyterian ethos. General Assembly and Executive Commission meetings will be rendered useless and a share waste of time and resources if the compliance levels to the decisions made in these meetings are not adhered to.

11. MONITORING AND EVALUATION OF THE UPCSA STRATEGIC PLAN

The UPCSA strategic plan has been running for the past five years. The 2019 Executive Commission assigned ABC and Priorities& Resources (P&R) Committee with the responsibility of Monitoring and Evaluation of the UPCSA Strategic plan. Work by the two committees has started but not completed. We wish to ask the General Assembly to allow the two committees to bring a complete report covering the five years that the Strategic Plan has been implemented to the 2022 Executive Commission. We wish to support the proposals that P and R committee is bringing to this council asking that UPCSA Strategic plan be given another five years. We feel there is still a lot that needs to be done before we can move on to drawing another strategic plan.

12. EXECUTIVE COMMISSION 2022.

Having considered a number of factors we wish to propose that the 2022 Executive Commission be held virtually. Even when we hold the EXCOM Virtually we still need to have a hosting Presbytery. We have been in consultation with officials from Mthatha Presbytery and they have agreed to host the 2022 EXCOM. We suggest that the 2022 EXCOM be held within the bounds of Mthatha Presbytery from Sunday 26th to Thursday 30th June 2022.

Bio Data for Rev Jennie Nyirongo

The Rev. Jennie Moyo-Nyirongo is Minister of M'chinga Presbytery at Garden Congregation in Lusaka Zambia. Rev Nyirongo was born on 5th April 1961 in Ndola, Zambia. She is a widow who has nine children. She currently holds a Bachelor of Theology degree from Justo Mwale University where she graduated in 2001.

Rev Nyirongo served her probation at Matero Presbyterian Church from 1989 to 1990. She became a Minister of the same congregation in 1991. After serving for ten years at Matero Congregation, Rev Nyirongo was transferred to Kaunda Square Congregation in 2002. She did not stay long at Kaunda Square Congregation as she had to proceed to Wales in the United Kingdom in 2003 to take up a position as a Mission Enabler with the Presbyterian Church, working in Presbyteries of Cheshire, Flint and Denbigh. Her responsibilities as an enabler in Wales included drawing outreach programmes for the Presbyteries and conducting workshops and seminars on mission. She was involved in connecting the congregations with nearby schools and hospitals and working with Ministers to create activities which attracted young people to be involved in the life of the Church. She was in Wales until 2007. After her term ended in Wales, She returned to Zambia and was inducted Minister at Garden Congregation where she is still serving to date.

Rev Nyirongo has also served in various boards in Zambian Christian organisations. She was Vice Chairperson at Council of Churches in Zambia (CCZ) from 1999 – 2000. Because of her hard work, she was reappointed as Board member of the CCZ in 2015 to 2018. She also Chaired a CCZ Communications Committee from 2015 to 2018. In addition, Rev Nyirongo has been a Board Chairperson for Christian Alliance for Children in Zambia since 2016 to date. Further Rev Nyirongo was Vice Chairperson of Theological Education by Extensionin Zambia (TEEZ) from 2014 to 2018 where she served the organisation diligently.

In our on denomination, Rev Nyirongo has served in many capacities starting with being Moderator of Central Zambia Presbytery in 1998 – 2000. She also served as Moderator Synod of Zambia from for two which ended in 2018.

IN MEMORIAM MINUTE

Supplementary Report to the General Assembly 2021:

THE REVEREND PATRICK SIMON MHIKE

The Reverend Patrick Simon Mhike was born on the 1st August 1955 at Gweru Hospital in Zimbabwe. He grew up in a Christian family. He attended his schooling in Gweru from Primary to Secondary school and he successfully completed "O" level in 1976 at Chingwizha Secondary school. He completed his Diploma in Philosophy at Chishawasha Seminary in Harare. In 1981-1983, he was an assistant teacher at Rutunga Primary School. Again in 1983 -1994, he was employed as an assistant teacher at Chizhou Secondary School. In 1983, he joined Trinity Presbyterian Church in Gweru. In 1984 he was ordained an elder whose primary responsibility was to grow Sunday school which was coupled with promoting children's ministry across the spectrum. It was in 1985 when he tied the knot with his lovely and caring wife "Beauty" and was blessed with four children. In 1988-1991 he studied at the Theological College in Zimbabwe where he obtained a Licentiate in Theology. At the end of 2003, the Rev Patrick Simon Mhike received Bachelor of Theology from the University of South Africa.

In 1991 he successfully completed his first year of probation at Jube Presbyterian Church under the mentorship of the Rev Phiri. He then completed his second year of probation at Sakubva Presbyterian Church, and this time his supervisor was the Rev Rory Spence. The Reverend Patrick Simon Mhike was ordained as a Minister of Word and Sacrament in Presbyterian Church of Southern Africa, in January, 1993 at Sakubva Presbyterian Church in Mutare. When God extended a call to the Rev Patrick Simon Mhike, he never looked back. He remained faithful and committed to the life, work and witness of the church to this day.

During his ministry in the church, he served various pastoral charges with great humility and a gentle spirit: Sebokeng Presbyterian Church in the Presbytery of Lekoa (1997-1999).Ramoeti Masemola United Charge in the then Free State Presbytery (2000-2004).St John's Presbyterian Church-Batho in Bloemfontein (2005-2010).St Andrews Kgotsong in Trans Xhariep Presbytery (2011-2021).Again at Presbytery level ,the Rev Patrik Simon Mhike served as the Moderator of the then Free State Presbytery from 2010-2014.He served with distinction the following committees of Presbytery: Convener of Special Ministry, of Mission and Discipleship, and as Ministry Convener. Rev Patrick Simon Mhike was due to retire on the 31 December 2021, after faithfully serving Trans Xhariep Presbytery for 21 years of selfless service.

Patrick went to be with the Lord on 16 June 2021.

DRAFT REPORT OF THE NOMINATIONS COMMITTEE TO THE 2021 GENERAL ASSEMBLY OF THE UNITING PRESBYTERIAN CHURCH IN SOUTHERN AFRICA HELD VIRTUALLY FROM 26 JUNE TO 2^{ND} JULY 2021.

1. Purpose:

1.1 The purpose of the report is to present proposals on the Nomination of Committee of the General Assembly for the 2021-2023 Assembly Years.

2. Introduction

- 2.1 Greetings to the Moderator of General Assembly, the Right Rev. Sipho Mtetwa, past moderator, General Secretary, Clerk of Assembly, Office bearers, commissioners and members of the UPCSA at large, I greet you in the name of our Lord and Savour Jesus Christ.
 - It gives me great pleasure to have the opportunity to present the draft report of the Nominations Committee to the General Assembly.
- 2.2 The work of the Committee was not easy due to the uncertainty arising out of the outbreak of Covid 19 in the country and the world. While the Pandemic has forced us to learn new ways of doing business in the form of virtual engagements, however it remains a challenge that not all people find it easy to use these platforms for meetings. The Committee has also learned that the systems are also unreliable as networks tend to let us down and interfere with ability to communicate effectively.
- 2.3 The Committee has noted with appreciation that almost all Presbyteries have nominated commissioners to serve in the Committee during the cause of the Assembly, and this should make the consultation process effective.
- 2.4 The Committee would like to express profound appreciation to the General Assembly Office for the support it provided which enable the Committee to perform its work.

3. Legislative Requirements

- 3. 1 Chapter 13 of the Manual of Faith and Order provides for the General Assembly to establish Commissions and Committees it needs to carry out its functions and perform its duties and for the determination of the terms of reference of such committees and commissions.
- 3.2 Section 2 of chapter 13 (as amended) of the Manual of Faith and Order sets out the terms of reference of committees of Assembly.
- 3.2 Section 13.59 of the Manual provides for the Assembly to establish a Nominations Committees whose duties shall to propose names of persons to serve in Committees for Assembly's approval.
- 3.4 Section 4.2.1 of the Assembly Standing Orders outlines the process for the development of the Nominations Report, the presentation of the Draft report as well refinement of the same for final adoption by the Assembly.
- 3.5. The Policy on Nomination of Committees of Assembly provides guidance on how the Nominations Committee must conduct its work, with special emphasis on the consultation process that must guide the nomination of persons to serve in Committees of Assembly.

4. Exposition of Facts

The Nominations Committee presented a Policy on the Nominations of Committees of Assembly, which was approved by the 2019 Executive Commission. However the outbreak of Covid 19 meant has made it difficult for the Committee to fully implement the provisions of the Policy in terms of early consultation of Committee Convenors. However prior to the finalization of the report prospective convenors

have been consulted and most have agreed to be nominated into the committees as reflected in the report. In Nominating Committee convenors the Committee has sought to increase female Convenership of committees to one third of the total number of Committees as this in crucial in the process of transformation of the denomination. The Committee is also working on increasing youth representation in committees while also ensuring racial balance and clergy/laity participation in Committees.

5. Recommendations

5.1 That the General Assembly receives the report.
